## Can you say "yes" to any of the below?

- Q** Do you have a child or spouse diagnosed with asthma, attention deficit disorder, cancer, diabetes, lupus, heart disease, leukemia, mental illness or any other physical, emotional, and/or developmental disability?
- Q** Do you have a child in special education: IEP, ISFP or a 504 plan?
- Q** Do you have a dependent child over 21 in the incapacitated dependent program?
- Q** Do you have a family member in a residential treatment facility?
- Q** Are you enrolled in the TRICARE Standard Program for the Disabled?
- Q** Do you have a spouse or child receiving medical care through a state medical program?
- Q** Do you have a family member receiving Supplemental Security Income (SSI) benefits?
- Q** Are you a geographic bachelor because of a family member's special medical or educational needs?
- Q** Do you have a family member in a full-time special education setting or receiving inpatient/facility care?

Once your family is identified as EFMP, contact your EFMP Case Liaison for information on how to submit enrollment forms.

# What is EFMP?

## EXCEPTIONAL FAMILY MEMBER PROGRAM

EFMP is a mandatory program and requires enrollment of all dependents (adults and children) with special medical, educational, developmental, and/or emotional needs or concerns.

The Navy's Exceptional Family Member Program (EFMP) assists Navy families with special needs to include:

- Specialized Medical and Dental care
- Developmental requirements
- Special Education requirements
- Accessibility/Adaptive equipment
- Assistive Technology devices and services
- Specific mental health conditions



## EFMP CASE LIAISONS

### What is a Case Liaison (CL)?

A Case Liaison (CL) is a Fleet & Family Support Center staff member assigned to each sponsor/family who is enrolled in the EFMP.

### What does a Case Liaison (CL) do?

- Provides information and referral to resources within their assigned area (rather than in San Diego area).
- Offers assistance in developing a Family Services Plan (FSP).
- Connects families with networking and social opportunities within the area.

Contact your local FFSC to connect to your local EFMP Case Liaison (CL).

## EFMP COMMAND POC

### What is an EFMP Command POC?

A Command POC is an active duty Service Member who serves in support of the EFMP at each command.

### What does a Command POC do?

- Monitors EFM enrollment status and expiration dates for their command.
- Collaborates with EFMP case liaisons.
- Assists with the enrollment, update and disenrollment processes.

## MTF COORDINATOR

### What is an MTF Coordinator?

An MTF Coordinator is directly responsible for the enrollment and re-enrollment processes.

### What does an MTF Coordinator do?

- Reviews and verifies information submitted in the application for accuracy and uploads forms to the NFAAS system for processing.
- Accepts application forms (DD 2792/DD2792-1) that have been hand delivered to their office for submission.

### 2. Regional EFMP Special Education Liaison

Navy Region EFMP SPEC ED Liaison can provide:

- Support to Navy EFMP families with special education needs as it pertains to Individual Education Programs (IEPs), 504 plans, and associated plans to support the special educational needs of military children with special needs
- Review of IEPs and Section 504 plans with Navy families whose Special Education needs are beyond the scope and expertise of FFSC EFMP Case Liaisons

### 3. EFMP Case Liaisons (CLs)

Navy EFMP CLs can provide:

- Assistance with navigation of systems; provide information/ referral services, and non-medical case management
- Provide a connection between military, local, and national community resources and the EFMP families who utilize support services

### 4. School Liaison Officers (SLOs):

SLOs can:

- Offer assistance in navigating the administrative systems within local public schools.
- Provide information about programs and services available on the installation and in the local community.
- Make referrals to the appropriate special education professionals
- Provide information concerning local school policies and regulations pertaining to special education
- Can assist families with the required signatures for EFMP enrollment form DD 2792-1.
